Note that all fees must be paid before your access card can be picked up.

Admin fees will not be accepted at the garages.

Parking Agreement - Rights and Responsibilities Initial 1. Access Card Use: This access card authorizes one (1) electric vehicle (EV) to park in the City-owned parking garage(s) assigned to the access level selected. No definite space will be assigned nor will availability be guaranteed. The access card is for the sole use of the registered access card holder to park the registered EV and is non-transferable. Daily market rates will apply if card holder does not use the card for entry or exit. The access card must be used in sequence by scanning it at the entrance and then the exit. If access card is used out of sequence, it will automatically become inactive. No overnight parking allowed unless authorized by the Parking Services Division Manager. The City of Sacramento reserves the right to relocate monthly parkers to another City-managed facility in the event of overflow or space limitations in the garage. 2. Payment: For Global EV Customers, full payment is due on or before the 1st of each month. A \$25.00 late fee per card will be charged on the 6th calendar day if full payment is not received on or before the 5th of the month. If all fees due are not received by the 10th day, the access card registered under the account will be deactivated until the account has been paid in full. All delinquent amounts plus a \$25.00 reactivation fee must be paid before the access card can be reactivated. Access card owners will be responsible for any and all fees resulting from delinquent payments. **Payment Options:** a. Automatic Credit Card Deduction: Credit cards will be deducted in the first week of each month. Payments by Mail: Only checks and money orders will be accepted. Please list account number on check. Please make checks payable to: City of Sacramento. Cash Customers: Cash paying customers must visit the Customer Service Counter during regular office hours. 3. Rates: An administrative fee will be imposed for all new, lost, stolen, or damaged access cards. Per City Council Resolution No. 2000-646, vehicles powered exclusively by electricity shall park at no charge in garages owned and operated by the City. Once EV parking transactions exceed the threshold allowed to maintain free monthly parking access at any garage, the garage will be included in the Global EV Access program per City Council Resolution (Amendment) 2000-646. The EV Parking Access Rates are as follows (subject to change): **Limited EV Access:** This card allows free parking access at any City of Sacramento parking garage that does not require payment of a monthly fee per City Council Resolution. Locations subject to change. Visit www.sacpark.org for the list of qualifying garages. Global EV Access: This card allows access to all City-owned garages at a reduced monthly rate. Price and location subject to change. Please refer to www.sacpark.org for current pricing. 4. Recharging Stations: Locations of EV charging stations and charger types are available online at www.sacpark.org by clicking on Discount Programs and choosing Electric Vehicle Parking.
